



Agree to Terms & Conditions

CONSENT & RELEASE

For the purpose of this Agreement, "Business Proposal" means, as applicable, any and all information, data, methods, ideas, presentations, and strategies, whether copyrighted, trademarked, or not, relating to the business idea proposed, including but not limited to the business plans, the products and/or services the business provides, the prototype and the models.

I understand that I am being considered as a participant for the 2026 Fusion Credit Union Community Infusion program. By signing this Consent and Release (the "Agreement"), I represent that I have read, understood, and voluntarily agree to abide by its terms and conditions. Fusion Credit Union requires me to enter into this Agreement to be considered as a participant for the program, and I deem it to be in my best interest to enter into this Agreement. I acknowledge that by signing this Agreement, I will be giving up certain legal rights I may have against Fusion Credit Union.

In consideration of being considered for and possibly selected to participate in the Community Infusion program, (notwithstanding whether or not I am selected as a final participant for the program) and for other good and valuable consideration which I have received, I hereby represent and warrant that the following statements are true and correct and that I irrevocably agree to the terms and conditions contained herein:

1. I acknowledge that if the applicant is 18 years of age or older, the applicant may sign this Agreement on their own behalf. If the applicant is under 18 years of age, a parent or legal guardian must review and sign this Agreement on the applicant's behalf and consent to the applicant's participation in the Community Infusion program, including the recording and online publication of the applicant's video presentation for public viewing and voting.

Where the applicant is under 18 years of age, references in this Agreement to "I" and "my" include the applicant and, where applicable, the applicant's parent or legal guardian signing on the applicant's behalf.

If I am signing this Agreement as the parent or legal guardian of an applicant under 18 years of age, I represent and warrant that I am authorized to sign on the applicant's behalf and to provide consent for the applicant's participation in the Community Infusion program and for the



collection, use, recording, publication, and disclosure of the applicant's name, likeness, voice, and business proposal as contemplated by this Agreement.

2. I understand and acknowledge that applications will be accepted between July 15, 2026, and September 7, 2026, at midnight. Applications are to be submitted via www.fusioncu.com by utilizing the applicable application form link.
3. I understand and acknowledge that my submission for the grant money is for a new business/business idea, an existing business I am looking to purchase, or the expansion of a current business.
4. If I am chosen as one of the winners, I understand and agree to open a membership with Fusion Credit Union, and that I meet the qualifications to open a membership.
5. I understand and acknowledge that I may need to undergo investigations into my background, which may include reviews of civil and criminal records, financial, credit and employment history, and any other type of background deemed necessary by Fusion Credit Union, and I agree to sign all necessary consents or other documents in connection therewith.
6. I consent that I have answered the questions in the foregoing application truthfully, accurately, and completely and will immediately inform Fusion Credit Union if any information I have provided changes, is discovered by me to be false, inaccurate, or incomplete or becomes false or incomplete. If any of the information I have provided is found and/or determined by Fusion Credit Union in its sole discretion to be false, incomplete, inaccurate, or otherwise misleading, Fusion Credit Union reserves the right to immediately dismiss and disqualify me from the participant selection process and/or from the program, if selected.
7. I understand and acknowledge that if I am chosen as one of the finalists for the Community Infusion program, Fusion Credit Union, or its representative, will record a video presentation of me and my business idea.
8. I understand that my recorded video presentation will be posted on publicly accessible online platforms for viewing by members of the public and for the purpose of public voting, and that the results of such voting will be considered in determining grant funding.
9. I understand and acknowledge that any information I disclose in my recorded video presentation, including information relating to my business idea, business plan, products, services, branding, or strategy will become publicly available once the video is posted online, and Fusion Credit Union is not responsible for protecting such publicly disclosed information.
10. I understand and acknowledge that if I am the successful recipient of the grant money, it will be disbursed at the discretion of Fusion Credit Union.
11. I understand that the purpose of Community Infusion is to showcase participants' business concept, expansion, or revamp through recorded video presentations that will be made available online for public voting to determine grant funding. I acknowledge and confirm that Fusion Credit Union does not guarantee that any transaction of grant money will occur until all requirements of the participant are met.



12. I hereby irrevocably consent to Fusion Credit Union recording me in audio and/or video format for use in connection with the Fusion Credit Union Community Infusion program. I hereby grant to Fusion Credit Union the right in any and all media now known or hereafter devised throughout the universe in perpetuity to use and reuse my appearance, voice, and the Business Proposal in connection with the recorded video presentation and public voting process, including making the video available online for viewing and voting. Personal information shall not be used or disclosed for purposes other than those for which it was collected, except with the consent of the individual or as required by law. Personal information shall be retained only as long as necessary for the fulfillment of those purposes.

14. I agree that my selection as a participant of the Community Infusion program is within Fusion Credit Union's sole discretion, and that Fusion Credit Union is not obligated to select me. In addition, if I am disqualified as a participant, Fusion Credit Union may make an explanation or announcement as to the reason why I was disqualified.
15. I acknowledge and agree that Fusion Credit Union may, at any time and in its sole discretion, add, remove, or replace participants for any reason.
16. I consent that I am not a previous winner of Community Infusion grant money.
17. I consent that I am not an employee, officer, director, agent or representative of Fusion Credit Union or any subsidiaries of Fusion Credit Union.
18. I consent that to the best of my knowledge, I am not the immediate family member (as defined in #20 below) of an Executive Manager, or Board of Director of Fusion Credit Union or any subsidiaries of Fusion Credit Union.
19. I consent that I am not the immediate family member (as defined in #20 below) of a Community Infusion coach or Community Infusion project team member (names will be provided upon receipt of application).
20. Immediate family is defined as:
 - a. Spouse, parent, child, grandparent, or sibling (including full, half, step, or adoptive)
 - b. A relative through marriage including spouse's parent, child, grandparent, or sibling (including full, half, step, or adoptive)

22. I understand and acknowledge that I will be disqualified from the Community Infusion program if items 16, 17, 18 and 19 above apply to me as an applicant.
23. I acknowledge that I will be ineligible to receive grant money if I am disqualified from the Community Infusion program.
